Each candidate was judged on notable contributions in his or her life which would serve as a role model for children. Each candidate's outstanding leadership and dedication to children and their service to our community were important factors in the selection process. Serves on Shelton's Board of Aldermen and the Planning and Zoning Commission. Member of the Boys & Girls Club of the Lower Naugatuck Valley Board of Directors. Major supporter of



both the Boys & Girls Club LNV John "Red" Larsen Golf Classic and the Alumni Golf Tournament, golf committee member.
